

Greening of Lindsay Park Continues with Selection of Hess for Oil-to-Gas Conversion

Lindsay Park Converts to Natural Gas to Cut Costs, Reduce Greenhouse Gas Emissions and Meet NYC Regulations

WOODBRIDGE, N.J., March 12, 2012 /PRNewswire/ -- Lindsay Park Housing Corporation in New York City has selected Hess Energy Solutions, part of Hess Corporation (NYSE: HES), to convert its 10 boilers from No. 6 heating oil to cleaner-burning natural gas. Hess is managing the conversion from start to finish, providing turnkey project management and funding as part of a natural gas supply agreement, which eliminates the need for upfront capital or bank financing.

In 2011, New York City passed regulations that require building owners to discontinue use of heavy fuel oil to heat commercial and residential buildings and switch to cleaner-burning fuels with lower sulfur content. In addition to managing the boiler conversion, Hess provided the documentation needed for Lindsay Park to take advantage of approximately \$227,000 in NYSERDA incentives for converting from fuel oil to natural gas as well as a \$200,000 rebate from National Grid, payable upon completion, for the installation of natural gas piping.

Once the project is completed in the second quarter of 2012, Lindsay Park plans to use natural gas supplied by Hess for its seven buildings, well ahead of local legislative requirements. This project is expected to reduce Lindsay Park's annual energy costs by approximately 30 percent after five years with no upfront capital expenditure.

"Lindsay Park's boilers were more than 40 years old. Converting them to natural gas was an opportunity to make Lindsay Park more energy efficient while we met the new regulatory requirements," said Cora D. Austin, president of the board of directors for Lindsay Park Housing Corporation, located in Brooklyn. "We have a long relationship with Hess, so when they shared how we could convert to cleaner-burning natural gas without the need for an upfront capital investment, our board was definitely interested in acting now."

Built in the mid-1960s, Lindsay Park Housing Corp., a cooperative apartment corporation within New York City's Mitchell-Lama program, is one of the city's largest housing complexes with 2,702 units in seven buildings. Over the past few years, Lindsay Park has made significant progress in updating its building infrastructure to be more energy efficient. In 2011, it used a \$12.9 million weatherization grant from the New York State Division of Housing and Urban Renewal to install new windows in each apartment, switch to energy-efficient, motion-activated lighting in common areas, clean duct-work in all unit bathrooms and kitchens, replace hot water pipes, upgrade to energy-efficient refrigerators in all eligible units, and install smoke detectors and carbon monoxide detectors throughout the complex. Prior to its energy-efficient conservation efforts Lindsay Park, through the efforts of its board of directors, management, and the New York City Department of Housing Preservation & Development, was the beneficiary of another multi-million dollar grant under the Federal Home Loans program. This grant was used to replace all 28 elevators, re-pave parking lots and sidewalks, and purchase roll-on/roll-off trash container/compactor units.
